- You can register multiple phone numbers and email addresses for notifications.
- If you do not answer a notification call, VINEWatch will leave a message and will continue calling back until you enter your PIN or until up to 24 hours have passed.
- Notification calls will be made between 7:00am and 10:00pm with respect to the time zone of the area code of the registered phone number.
- Do not register a phone number that rings to a switchboard.
- VINEWatch is confidential.
- If you forget your PIN, call the toll-free Alaska VINEWatch Courts phone number (1-888-231-8463) and press zero for a VINEWatch service representative.

REGISTRATION

If you are the victim or a witness in a court case, you can register to receive VINEWatch notifications on court hearings. **YOU MUST CONTACT THE PARALEGAL HANDLING THE CASE IN ORDER TO REGISTER.**

If you request to register a phone number, you must create a four-digit personal identification number (PIN) that you will need when you receive notifications. This PIN will be used to stop notification calls once the notification is made to your phone number. Make sure your PIN is easy to remember. Write it down and keep it in a safe place.

Email registrations do not require a PIN.

If you would like to register for court case hearing information, contact the paralegal handling your case. The paralegal will personally register the phone number(s) and/or email address(es) at which you would like to receive notification.

NOTE: The Alaska Department of Law VINEWatch service is separate from the Alaska Department of Corrections VINE Service. In order to receive notifications for court case hearings, you **MUST** register through the paralegal handling your case.



NOTIFICATION

Once registered, you will be notified about court hearings pertaining to the case.

When VINEWatch calls, listen to the message, then enter your PIN followed by the pound (#) key when asked. Entering the PIN lets VINEWatch know that you received the call and will stop the service from calling you again.

No PIN is required for email notifications. You will receive one email when there is an update to the court hearing or event.

You may receive multiple notifications in a row, so be sure to listen to each in its entirety.

NOTE: Rotary phones are not able to accept a PIN in order to stop the notification calls. For telephones with caller ID or Anonymous Block, a notification call will show up with a "502" area code.
