### Count I

That in the Third Judicial District, State of Alaska, on or about April 29, 2018, at or near Anchorage, VANCE I PERONTO, a 57-year-old man, with the intent to commit the crime of a sexual abuse of a minor in the second degree, took a substantial step towards engaging in the offense of sexual abuse of a minor in the second degree with R.P., a person who was 16 or 17 years of age and at least three years younger than the offender, and the offender occupied a position of authority in relation to the victim as defined by AS 11.41.470(5).

All of which is a Felony class C offense being contrary to and in violation of AS 11.41.436(a)(6) and AS 11.31.100 and against the peace and dignity of the State of Alaska.

All of which is a Felony class B offense being contrary to and in violation of AS 11.41.455(a)(6) and against the peace and dignity of the State of Alaska.

### **Count III**

That in the Third Judicial District, State of Alaska, on or about April 11, 2018, at or near Anchorage, VANCE I PERONTO with the intent of producing a live performance, film, video, electronic, or electromagnetic recording, photograph, or other material that visually or aurally depicted the lewd exhibition of the child's genitals, knowingly induced R.P., a child under 18 years of age to engage in, or be photographed, filmed, recorded, or televised while engaged in the actual or simulated conduct of the lewd exhibition of the child's genitals as depicted in "unified message 2096090917333614.mp4."

All of which is a Felony class B offense being contrary to and in violation of AS 11.41.455(a)(6) and against the peace and dignity of the State of Alaska.

### **Count IV**

That in the Third Judicial District, State of Alaska, on or about April 17, 2018, at or near Anchorage, VANCE I PERONTO with the intent of producing a live performance, film, video, electronic, or electromagnetic recording, photograph, or other material that visually or aurally depicted sexual penetration and / or masturbation, knowingly induced R.P., a child under 18 years of age to engage in, or be photographed, filmed, recorded, or

televised while engaged in the actual or simulated conduct of sexual penetration and / or masturbation as depicted in "unified message 2099022340373805.mp4."

All of which is a Felony class B offense being contrary to and in violation of AS 11.41.455(a)(1) and / or AS 11.41.455(a)(4) and against the peace and dignity of the State of Alaska.

### Count V

To wit: the defendant knowingly possessed "unified message 2099022340373805.mp4."

All of which is a Felony class C offense being contrary to and in violation of AS 11.61.127(a) and against the peace and dignity of the State of Alaska.

### **Count IX**

That in the Third Judicial District, State of Alaska, on or about April 17, 2018, at or near Anchorage, VANCE I PERONTO knowingly possessed or knowingly accessed on a computer with intent to view material that visually depicts conduct described in AS 11.41.455(a)(1) and / or AS 11.41.455(a)(4), knowing that the production of the material involved the use of a child under 18 years of age who engaged in the conduct. To wit: the defendant knowingly possessed "unified message 2099022383707134.mp4."

All of which is a Felony class C offense being contrary to and in violation of AS 11.61.127(a) and against the peace and dignity of the State of Alaska.
